



MASLEÑA RESCUE FOUNDATION LIABILITY RELEASE AND HOLD HARMLESS AGREEMENT

I hereby acknowledge the risks involved in being around, working with, and riding horses and livestock, which include bodily injury from being near the animals.

Equines, by nature, are unpredictable, and as such, can, without warning, cause injury to humans. I am aware of this risk and still choose to be a part of the operations and events of Masleña Rescue Foundation (MRF). I further understand that injury from an equine or other animal can occur during routine procedural operations, such as walking near, interacting with, or standing around equines.

I understand that no unaccompanied children are permitted. No smoking is permitted. No pets are permitted. No horses are permitted to be trailered-in, without prior authorization by the operator. Horses with prior approval will be kept away from resident horses for safety and health reasons. Visitors are defined as riders, Ranch Hands, trainers, promoters, and impromptu guests. All visitors are required to adhere to posted safety and operational instructions.

It is the intent of MRF to provide a pleasant environment for all visitors. Your signature on this agreement is also an acknowledgement that you have read and will adhere to the rules as stated in this document given to you upon entrance to MRF. A copy of the New Mexico State Laws regarding equine operations is available at your request and we will be happy to discuss any concerns you may have relative to them.

I hereby, intending to be legally bound, for myself, my heirs and assigns, executors or administrators, waive and release forever all claims for damages against MRF, its Board of Directors, volunteers, and/or employees for all injuries and/or losses I may sustain while participating in any equine/livestock activity.

MEDICAL ASSIGNMENT

I hereby provide to MRF the instructions for my medical treatment. These instructions will be carried out on my behalf, if I am not able to seek medical assistance on my own. I further understand that MRF is obligated to call for emergency treatment (ambulance, paramedics, etc.) if an individual is injured and in need of immediate assistance. MRF may provide first aid as the result of an injury to me. MRF will do everything possible to contact the individuals on the emergency list I provide but may be limited by the criticality of the situation. Individuals listed as emergency contacts will be contacted as soon as possible after an accident/injury occurs.
